

# WAYFINDING & TOURISM DESTINATION SIGNAGE APPLICATION FORM



## Application Process

To apply for wayfinding signage along municipal road allowances under the Township of King Wayfinding and Tourism Signage Program, please complete and submit this form to the Township of King municipal offices at 2585 King Road, King City, ON, L7B 1A1 ATTN: Economic Development Officer.

There is a one-time fee of \$200 per directional sign requested, and a one-time fee of \$500 for participation on available billboard signs. Fees will not be requested until the application has been approved. The Program Administrator will contact you to verify application details and discuss specifics of your application prior to approval and request for payment of fees.

## Eligibility Requirements

To be eligible for the program, applicants must meet the following criteria:

1. Be in compliance with all municipal, provincial and federal regulatory statutes & by-laws
2. Be open to the general public, with consistent and regular hours of operation
3. Be accessible by public roads and have signage on property to be identifiable from public roads
4. The business must conform to one of the following uses:

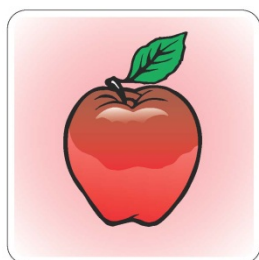

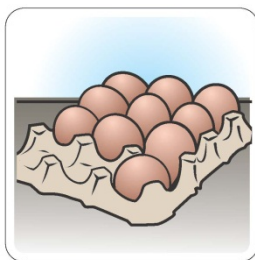

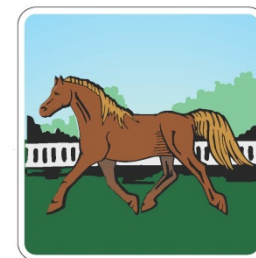

## Terms and Conditions

By submitting this application, the applicant agrees to abide by the following terms and conditions:

1. The applicant must meet all eligibility requirements specified in the Township of King *Wayfinding & Tourism Destination Signage Policy*.
2. All program signage shall adhere to the general design principles specified within the Policy.
3. No more than four (4) directional signs and one (1) billboard sign space are permitted per applicant.
4. Directional signs are to be located within 5 kilometres traveled road distance from the applicant's location. Billboard sign space will be available to those participating businesses or uses that are within 10 kilometres traveled road distance from the billboard sign.
5. Applicants are encouraged to identify preferred sign locations on their application, however the Township reserves the right to select the final location of all program signs to ensure road safety.
6. Following approval of an application, the applicant shall pay the full sum of all fees incurred before any signage is installed. Fees are non-refundable following construction of signs.
7. In the event of a conflict between the eligibility criteria, design standards, and location standards of the Policy and the submitted details of an application, the Township reserves the right to determine the final eligibility of the application and location of program signage when installed.
8. Participation may be refused or revoked if an applicant does not meet the eligibility criteria, ceases providing the service or good being advertised, falsifies or misstates information on their application, or if the approval is issued in error.
9. Program signage shall be under the ownership of the Township of King and shall be installed and maintained by the Township. In the event that a program sign must be replaced in its entirety, the applicant will be required to pay the full fee for a new sign.
