## King is Hiring Aquatics Manager

Reporting to the Recreation Supervisor, the Aquatics Manager is responsible for the following:

- Responsible for and oversees scheduling of all staff shifts.
- Responsible for managing aquatics budget.
- Oversees all aspects of the operations at the Nobleton Outdoor Pool, including, basic pool maintenance, staff training, and supervision of staff and patrons.
- Oversees the delivery of Lifesaving Aquatics programs and life guarding.
- Ensures health and safety policies and procedures of the facility are practiced.
- Develops and delivers a comprehensive staff training for all aquatics staff including swim instructors and lifeguards.
- Enforces health and safety regulations and conditions as required to the nature of the activity.
- Ensures that department policies and procedures are adhered to by the public and aquatics staff.
- Takes appropriate action to deal with incidents, problems and emergencies as outlined by departmental policies and procedures
- Other duties and responsibilities as assigned.

The successful applicant will possess:

- Current Standard First Aid Certification and CPR "C" with AED (Lifesaving Society, Red Cross, St John's Ambulance or Canadian Ski Patrol)
- Current National Lifeguard Service certification (NLS) from either Red Cross or Lifesaving Society.
- Current Lifesaving Instructor certification
- Current Lifesaving SWIM Instructor certification
- Current Lifesaving Aquatic Supervisor certification (or equivalent)
- Current Lifesaving Aquatic Supervisor Instructor (or equivalent) is considered an asset.
- Demonstrates knowledge of facility systems for pool water circulation, filtration and daily maintenance.
- Must have teaching and guarding aquatics experience.
- 1-2 years of staff supervisory experience.
- Valid First Aid and CPR certificates.
