Function:

The Inclusion Camp Counsellor is specifically employed to work 1:1 or 2:1 with children and youth who require additional support. They engage camp participants in interactive activities including organized arts and crafts, singing, sports activities, games, and field trips, while maintaining a safe environment.

Supervision Responsibilities:

None

Duties and Responsibilities:

- Provides 1:1 or 2:1 supervision of camper(s).
- Ensures a safe, and comfortable environment for the camper.
- Assists camper in all needs outlined in the camper/parent assessment.
- Works with individuals who are physically impaired, sensory impaired, have speech and language difficulties, are emotionally vulnerable, have behavioural difficulties, or have a combination of these exceptionalities.
- Develops, plans and organizes specialty instruction to accommodate the camper to ensure an inclusive camp experience.
- Models and practices HIGH FIVE®- Principles of Healthy Childhood
- Development (Participation, Play, Mastery, Friends and Caring Adult).
- Provides guidance and support to fellow staff, and volunteers to ensure inclusive programming is planned and implemented.

Education/Experience:

- Minimum of one (1) year of experience working with children with exceptionalities.
- Excellent communication, programming, and leadership skills.
- Non-Violent Crisis Intervention, Behaviour Management Systems, and/or Crisis
- Intervention Training certification is considered an asset.
- Valid First Aid & CPR-C Certification.
- HIGH FIVE® certification is considered an asset.

Conditions of Employment:

- Required to work outside and follow all operating procedures and safety policies of the Township of King.
- Required to deal courteously and effectively with the general public, staff and other departments.
- Upon hire, completion of HIGH FIVE® Principles of Healthy Child Development, Standard First Aid and CPR-C and submission of a Vulnerable Sector Screening are required.
- Must be 16 years of age or older
- Must be available to work the duration of the contract, in full.
- Hours of work will be between 7:30AM- 6:00PM, Monday to Friday.
- Hours of employment are based on the weeks of camper registration and support required. This is a Part Time offering. Inclusion Counsellors may not work all ten (10) weeks of summer, however there may be opportunities for a camp counselor position if interested.
