Agricultural Farm Building Permit Application Guide



Description

A building permit for an Agricultural Farm building including silos, barns, manure storage facilities, grain bins, shops, etc.

General Information

A building permit is required for an Agricultural Farm building larger than 10 m². The Ontario Building Code (OBC) together with The National Farm Building Code of Canada (NFBC), regulates the construction of farm buildings in Ontario.

The OBC defines farm buildings as all or part of a building,

- a) That does not contain any areas used for residential occupancy,
- b) That is associated with and located on land devoted to the practice of farming, and
- c) That is used essentially for the housing of equipment or livestock or the production, storage or processing of agricultural and horticultural produce or feeds.

The design of Farm buildings should be undertaken by individuals who are experienced in agricultural building design. Special design considerations include some of the following: loads on floors due to heavy machinery, equipment, and livestock. Large roof truss spans can be susceptible to snow drift factors. Tall and partially open walls with large door openings can be susceptible to the effects of wind loading, etc.

Additional Requirements prior to building permit application

The Building Code Act prohibits the issuance of a Building permit if the proposed construction or demolition contravenes any Applicable Law as defined in the Ontario Building Code. Furthermore, **applications that do not have the required Applicable Law documentation with their building permit submission will not be processed.**

Please verify all approvals that may be necessary prior to submitting your application to construct. The following are examples:

- **Site Plan Development Approval/Agreement** (Township Planning Department)
- **Zoning Certificate** (King Townships Planning Department)
- **Approved Nutrient Management Strategy (NMS)**
- **Minimum Distance Separation (MDS) Calculation**
- **Site Characterization Study**
- **Ontario Farm Association Membership with a copy of your Farm Business Registration Number.**
- **Approval or Permit from Lake Simcoe Region Conservation Authority or Toronto Region Conservation Authority**

Required Drawings

Survey or Site Plan

Survey or site plan, referenced to a current survey, showing the size and location of all existing and proposed structures with distances to property lines, bodies of water, water wells as well as structures on adjacent properties. The location of existing and proposed septic tank(s) and leaching bed must be shown (*where applicable).

Floor Plans & Elevations - Architectural & Structural

Floor plans fully dimensioned for each level showing architectural and structural details including footings, foundation walls, slab, exterior walls, joists, rafters/trusses, lintels, and beams. Plans to show the use of all spaces including the location of all washrooms, type of plumbing fixtures and floor drains. Drawings of all four exterior elevations with floor to ceiling heights and overall building height.

Sections & Details

Cross section(s) to show building construction specifications of all floors, wall, and roof assemblies. Identify required fire-resistant ratings for such wall, floor, ceiling, and roof assemblies where applicable. The design of larger farm buildings must include fire safety requirements, fire and spatial separations, fuel storage tanks, exits and health requirements such as waste disposal and ventilation in compliance with the Ontario Building Code.

Note: Drawings prepared by a qualified Designer as defined by the Ontario Building Code, must include designer's name, Building Code Identification Number (BCIN), signature, and statement that the designer has reviewed and takes responsibility for the design and meets the qualifications set out in the Ontario Building Code as a Designer or other/independent Designer.

- **Schedule 2, Sewage System Installer Information * if required.**
- **Commitment to General Review by Engineer**
- **Owner's Authorization Form**

Exemptions - Schedule 1

If drawings are prepared, stamped, and signed by a qualified Engineer or Architect, they are exempt from submitting a Schedule 1.
