## **Terms and Conditions**

### **Medical Authorization**

On behalf of myself and all participants listed above, I give permission to the Township to arrange for emergency medical care including but not limited to hospitalization and /or transportation to a local doctor or hospital for medical treatment if necessary, and I consent on behalf of myself and the participants listed below, to the administration of such medical treatment, at my own expense.

### **Inclusion Support**

I acknowledge the Township offers adapted programming and 1:1 inclusion support. Adapted programming includes modified environments with smaller group sizes and increased group supervision, activities adapted to individual needs and goals. 1:1 inclusion support is provided for children who require extra support to participate in a recreation program, camp or swim lesson, pending staff availability. If I believe my child would benefit from 1:1 inclusion support I will reach out to [inclusion@king.ca](mailto:inclusion@king.ca) and notify them of triggers and methods that are helpful for my child. ### **Code of Conduct – Campers and Parents**

On behalf of myself and all participants listed above, I acknowledge the Township is committed to ensuring a safe and respectful environment for everyone. Facility users and guests are responsible for their personal conduct and must behave kindly and respectfully toward others. Unacceptable behaviour includes but is not limited to:

- Acts of racism or discrimination including displaying any intolerance of human rights;
- Committing physical assault, violence or destruction of property;
- Using abusive, offensive, or foul language, or engaging in name-calling;
- Persistently displaying rudeness, bullying, taunting, or patronizing behaviour;
- Behaving in an unreasonable, frivolous, and/or vexatious manner likely to cause distress, disruption or irritation, without proper or justified cause;
- Behaving illegally or violating King Township policies and procedures; and,
- Refusing to follow staff directions.

Failure to comply with the Code of Conduct may result in being asked to leave the site or program, and/or possible suspension or expulsion from future programs, events, memberships, and facilities.

### **Illness Prevention**

I acknowledge that if my child has symptoms like diarrhea, vomiting, or a fever greater than 37.8°C, they should remain at home. They should stay home from camp for at least 24 hours after

their symptoms are gone, without the aid of medicine. This waiting period further protects the public by ensuring they're fully recovered and no longer contagious. In the event a camper experiences any of these symptoms while attending camp, their parent/guardian will be contacted to pick up the child immediately. This criteria is established under the Illness Prevention Procedure (PRC-PRO-112) and the HIGH FIVE Standards Policy (ADM-POL-152).

### **Public Conduct – Campers and Parents**

I further acknowledge that failure to abide by the Code of Conduct, the Illness Prevention Procedure, and/or the HIGH FIVE Standards Policy, can result in the Public Conduct Policy being applied. Invoking this policy could have serious consequences for myself and the participants listed, including restricting my or their access to Council Members, Township Staff, services and/or property.
