Highway 400 Widening from Major Mackenzie Drive to King Road

Dear Sir / Madam,

The Ministry of Transportation of Ontario (MTO) has retained Morrison Hershfield to complete the design and prepare the contract package for ultimate widening from 8-lanes to 10-lanes on the Highway 400 by adding in one (1) general purpose lane (GPL) in each direction on Highway 400 from 1500 m south of Major Mackenzie Drive to 2000 m north of King Road in the City of Vaughan and Township of King.

We are notifying you that the final phase of the ultimate widening of Highway 400 to 10-lanes will be proceeding forward.

This project was classified as a Group B Project under the Class Environmental Assessment for Provincial Transportation Facilities (1999, amended 2000). The Detail Design and Class Environmental Assessment (EA) Study (W.P.s 192-00-00 and 2539-04-00) was completed in 2013 for the interim (8-lanes) and ultimate (10-lanes) widening for Highway 400 between Major Mackenzie Drive to King Road. The ultimate widening to 10-lanes including public consultation was completed and documented in the 2013 Design and Construction Report for the Detail Design and Class Environmental Assessment Study for the widening of Highway 400 from Major Mackenzie Drive to King Road (W.P.s 192-00-00 and 2539-04-00).

Construction, under Contract 2017-2001 (Highway 400 between Major Mackenzie Drive to King Road), of the interim 8-lane configuration (2 High Occupancy Vehicle [HOV] lanes and 6 GPL) with the highway platform widened to accommodate the ultimate 10-lane configuration (2 HOV and 8 GPL) is anticipated to be completed in late summer / fall 2022. The preparation of the contract package will complete the ultimate widening of Highway 400 to a 10-lane configuration from Major Mackenzie Drive to King Road and undertake the required modifications to existing ramps and infrastructure within the project limits. Lane and ramp closures are anticipated throughout the project area during off-peak times
