Important Information and Notes

1. Preliminary Maximum Contributions to a Candidate's Own Campaign are calculated in accordance with subsection 88.9.1(1) as the lesser of:
 - Mayor: \$7,500 plus 20 cents for each elector entitled to vote for the office, or
 - Councillor: \$5,000 plus 20 cents for each elector entitled to vote for the office; and,
 - \$25,000

2. Preliminary Maximum Campaign Expenses are calculated in accordance with Ontario Regulation 101/97 as follows:
 - Mayor: \$7,500 plus \$0.85 for each elector entitled to vote for the office;
 - Councillor: \$5,000 plus \$0.85 for each elector entitled to vote for the office;
 - School Board Trustee: \$5,000 plus \$0.85 for each elector entitled to vote for the office.

3. The Maximum Amount for Parties, etc. after Voting Day is 10% of Maximum Campaign Expenses as per O.Reg. 101/97, s. 6.

4. The final Certificate of Maximum Campaign Expenses will be issued in September 2026. The higher of the two will be considered the maximum campaign expense limit for each office.

5. An expense shall not be incurred by or under the direction of a candidate outside of their election campaign period.

6. The Clerk's calculation is final.
