I, by signing below, in participating in the One of a King: Handmade Holiday Market, and in consideration of the organizing stakeholders and the Township of King (the "Township") allowing me to participate in this event and related activities, fully understand and agree to the following:

- 1. I will not be considered to be an employee or independent contractor.
- 2. No fee, payment, salary, wage or employee benefits (such as accident, disability, medical, dental or other insurance coverage) whatsoever will be paid to me and I will not be covered by Workplace Safety Insurance Board coverage.
- 3. I acknowledge that vendor activities may involve certain elements of risk or the chance of an accident and I hereby release the event stakeholders, the Town and its elected officials, officers, employees and agents and their respective successors, assigns, heirs, and executors from all claims for loss, damage, or injury, except for that which is caused solely by the negligence of the Township, its employees, or its agents.
- 4. I will abide by all One of a King: Handmade Holiday Market applicable policies and rules as may be amended from time to time and will follow all instructions of the appropriate event management staff in carrying out activities.
- 5. I will not use facilities, equipment and property without the approval of an event management staff.
- 6. I will not use facilities, equipment and property owned or rented by One of a King: Handmade Holiday Market organizers or by the Township for personal purposes.
- 7. I will immediately notify the appropriate event management staff of any incident that involves property damage or personal injury to me or any other person during my participation in event activities.

RE: Reminder of Proof of Vaccination Disclosure Prior to Entry into

Indoor Township Facilities for Purposes of Undertaking Works for

the Township as of November 1st, 2021

DATE: Friday, October 29th, 2021

To whom this may concern,

As part of the Township of King's efforts to reduce the spread of COVID-19, the Corporation has developed and implemented a corporate-wide Mandatory Vaccination Policy, pertaining to Township employees, vendors and contractors accessing indoor Township facilities for purposes of carrying out work for the Township of King.

As of **November 1**st, **2021**, any vendor and/or contractor who requires access to a Township facility to complete such works, will be <u>required</u> to show proof of vaccination (two confirmed doses, with a minimum of at least 14 days following the final dose) as a condition of entry. Any vendors or contractors who fail to disclose proof of vaccination will **NOT** be permitted to enter the facility. Acceptable proof of vaccination format includes downloaded or printed copies of your existing vaccine receipt or enhanced vaccine certificate with a QR code. Township staff are also required to confirm that the name and date of birth on the proof of vaccination matches the person's ID.

This correspondence being circulated as a reminder to advise your staff of this Township of King mandate, and to avoid any situations of entry refusal due to non-disclosure. Active Screening prior to entry will still be required, at which point the vendor/contractor will show their screening results and proof of vaccination to be permitted into the facility by a Township of King employee.
