

THE CORPORATION OF THE TOWNSHIP OF KING

BY-LAW NUMBER 2023-021

A BY-LAW TO AMEND BY-LAW 2022-040 BEING A BY-LAW TO IMPLEMENT AN ADMINISTRATIVE MONETARY PENALTY SYSTEM AND BY-LAW 2022-041 BEING A BY-LAW RELATING TO ADMINISTRATIVE MONETARY PENALTIES FOR VIOLATIONS OF THE TOWNSHIP OF KING PARKING BY-LAWS

WHEREAS the Township has approved By-law Number 2022-040, which establishes an administrative monetary penalty system for by-law offences, and By-law Number 2022-041, which establishes administrative monetary penalties system for parking by-law offences, in accordance with Section 102.1 of the *Municipal Act, 2001*, and O. Reg. 333/07;

AND WHEREAS the Township wishes to amend By-laws 2022-040 and 2022-041;

NOW THEREFORE the Council of The Corporation of the Township of King enacts as follows:

- 1. That, in accordance with By-law 2022-042, Being a By-law to Appoint Screening and Hearing Officers for the purpose of Administration of an Administrative Monetary Penalty System within the Township of King that Council hereby appoint those Hearing Officers as appointed by The Town of Newmarket within their Administrative Monetary Penalty System, for the purpose of conducting Hearings on-behalf of the Township of King.
- 2. Part 5 of By-law 2022-040 is hereby amended by **adding** (non-parking) after the words SCHEDULE "B" BY-LAWS to section 5.1b.
- 3. Part 5 of By-law 2022-040 is hereby amended by **deleting** the word 'Voluntary' and adding the word 'Early' to section 5.3.e (i).
- 4. Part 5 of By-law 2022-040 is hereby amended by **deleting** section 5.5 and **inserting** the following section therein:
 - "5.5. The amount due for a Penalty Notice issued pursuant to section 5.1 b. (non-parking), is:
 - a. The Early Payment amount set out in Schedule "B" for the related contravention if payment is received within fifteen (15) calendar days from the effective date of service of the Penalty Notice in accordance with this By-law; or
 - b. The Set Penalty amount set out in Schedule "B" for the related contravention if payment is received after fifteen (15) calendar days and within thirty (30) calendar days from the effective date of service of the Penalty Notice in accordance with this By-law; or
 - c. The Late Payment amount set out in Schedule "B" for the related contravention if payment is received after thirty (30) calendar days from the effective date of service of the Penalty Notice in accordance with this By-law."
- 5. Part 7 of By-law 2022-040 is hereby amended by **adding** the following section therein:
 - "7.21 Every Person who receives an upheld decision in a review by the Hearing Officer in relation to a Penalty Notice issued through the Administrative Monetary Penalty System established by this By-law shall be responsible for an additional fee of \$25 for the purpose of the Township recovering administrative costs associated to the Hearing Officer Review."
- 6. Schedule "A" to By-law 2022-040 is hereby amended by **deleting** the word "Voluntary" in the heading of Column 5.
- 7. Schedule "C" to By-law 2022-040 is hereby amended by inserting the following fee therein:

"ITEM FEE

Fee – Adjudication Fee

\$25.00"

8. This By-law shall come into effect on the date of enactment by Council.


