BY-LAW NUMBER 2020- 076

A BY-LAW TO AMMEND BY-LAW 2019-033, BEING A BY-LAW TO APPOINT A MUNICIPAL LAW ENFORCEMENT OFFICER FOR PARKING ENFORCEMENT ON PRIVATE PROPERTY

WHEREAS Section 15 of the Police Services Act, R.S.O. 1990, Chapter P.15, authorizes Councils to pass by-laws for appointing a municipal law enforcement officer;

AND WHERAS Section 227 of the Municipal Act ,S.O. 2001 as amended, Chapter 25, authorizes Councils to pass by-laws for appointing such officers and employees as may be necessary for the purposes of the Corporation, for carrying into effect the provisions of any by-law of the Council;

NOW THEREFORE the Council of the Corporation of the Township of King HEREBY ENACTS AS FOLLOWS:

- 1. That Schedule A of By-law 2019-033, be amended, as follows:
a. TO ADD Column 3, and a subtitle, being By-law Approval/Date;
b. TO ADD Doug Claughton, and Don MacIntosh, to Column 1;
c. To ADD 80 Burns Boulevard to Column 2 beside both Mr. Claughton, and Mr. MacIntosh; and
2. That the individuals named in Column 1 of Schedule A of By-law 2019-033, as amended, by this By-law be hereby appointed as Municipal Law Enforcement Officer for the purpose of enforcing By-law 2005-36, as amended, but only in respect to the corresponding properties identified in Column 2 of Schedule A, attached to By-law 2019-033, as amended, by this By-law;
3. THAT Doug Claughton of Private Parking Control and Traffic Services /PPC Security Services, and Don MacIntosh, employee of the mentioned company are hereby appointed as Municipal Law Enforcement Officer, for the Corporation of the Township of King for the purpose of enforcing Township of King Parking By-law 2005-36, as amended, specifically (1) park without consent, (2) park in a fire route and (3) park in a designated disabled space at the locations as identified on the attached Schedule 'A' to By-law 2019-022, as amended, by this By-law, including authority to tag and tow; and
4. THAT this appointment will terminate upon termination of the contracts/agreements between: (1) the property owner, and Mr. Claughton; and (2) Private Parking Control and Traffic Services /PPC Security Services and, Mr. MacIntosh.

READ a FIRST and SECOND time this 14th day of December, 2020.

READ a THIRD time AND FINALLY PASSED this 14th day of December, 2020.
