BY-LAW NUMBER 2021-096

**A BY-LAW TO AMMEND BY-LAW 2019-033, BEING A BY-LAW TO APPOINT A MUNICIPAL LAW ENFORCEMENT OFFICER FOR PARKING ENFORCEMENT ON PRIVATE PROPERTY**

**WHEREAS** Section 15 of *the Police Services Act*, R.S.O. 1990, Chapter P.15, authorizes Councils to pass by-laws for appointing a municipal law enforcement officer;

**AND WHERAS** Section 227 of the *Municipal Act*, S.O. 2001 as amended, Chapter 25, authorizes Councils to pass by-laws for appointing such officers and employees as may be necessary for the purposes of the Corporation, for carrying into effect the provisions of any by-law of the Council;

**NOW THEREFORE** the Council of the Corporation of the Township of King **HEREBY ENACTS AS FOLLOWS:**

1. **THAT** Schedule 'A' of By-law 2019-033, be amended, as follows:
  - a. **To ADD** 149 Church Street to Column 2 beside the officers listed in Column 1: and
  - b. **TO ADD** also add all locations in Column 2, to all officers by ensuring that Officers in Column 1 coincide with the locations in Column 2 and hereby authorizing each officer to carry out enforcement on each of the properties as identified.
2. **THAT** the individuals named in Column 1 of Schedule A of By-law 2019-033, as amended, by this By-law be hereby appointed as Municipal Law Enforcement Officer for the purpose of enforcing By-law 2005-36, as amended, but only in respect to the corresponding properties identified in Column 2 of Schedule A, attached to By-law 2019-033, as amended, by this By-law.
3. **THAT Doug Cloughton of Private Parking Control and Traffic Services /PPC Security Services, and Michael Pugh, employee of the mentioned company** are hereby appointed as Municipal Law Enforcement Officers, for the Corporation of the Township of King for the purpose of enforcing Township of King Parking By-law 2005-36, as amended, specifically (1) park without consent, (2) park in a fire route and (3) park in a designated disabled space at the locations as identified on the attached Schedule 'A' to By-law 2019-022, as amended, by this By-law, including authority to tag and tow; and
4. **THAT** this appointment will terminate upon termination of the contracts/agreements between: (1) the property owner, and Mr. Cloughton; and (2) **Private Parking Control and Traffic Services /PPC Security Services** and, Employees names listed in Column 1.

**READ** a **FIRST** and **SECOND** time this 1st day of November 2021.

**READ** a **THIRD** time **AND FINALLY PASSED** this 1st day of November 2021.
