## **BY-LAW NUMBER 2022-008**

## A BY-LAW TO AMEND BY-LAW 2019-033, BEING A BY-LAW TO APPOINT A MUNICIPAL LAW ENFORCEMENT OFFICER FOR PARKING ENFORCEMENT ON PRIVATE PROPERTY

**WHEREAS** Section 15 of *the Police Services Act*, R.S.O. 1990, Chapter P.15, authorizes Councils to pass by-laws for appointing a municipal law enforcement officer;

**AND WHERAS** Section 227 of the *Municipal Act*, S.O. 2001 as amended, Chapter 25, authorizes Councils to pass by-laws for appointing such officers and employees as may be necessary for the purposes of the Corporation, for carrying into effect the provisions of any by-law of the Council:

NOW THEREFORE the Council of the Corporation of the Township of King HEREBY ENACTS AS FOLLOWS:

- 1. THAT Schedule 'A' of By-law 2019-033, be amended, as follows:
- 2. THAT Rebecca Hart employee of Private Parking Control and Traffic Services / PPC Security Services, is hereby appointed as Municipal Law Enforcement Officer, for the Corporation of the Township of King for the purpose of enforcing Township of King Parking By-law 2005-36, as amended, specifically; (1) park without consent; (2) park in a fire route; and (3) park in a designated disabled space at the locations as identified on Column 2 of the attached Schedule 'A' to By-law 2019-033, as amended, including authority to tag and tow; and
- 3. THAT this appointment will terminate upon termination of the contracts / agreements between: (1) the property owners, and Mr. Claughton; and (2) Private Parking Control and Traffic Services /PPC Security Services and, Employees names listed in Column 1.

READ a FIRST and SECOND time this 7th day of February 2022.

READ a THIRD time AND FINALLY PASSED this 7th day of February 2022.
