## BY-LAW NUMBER 93-93

## A BY-LAW TO PROVIDE FOR THE REMOVAL OF SNOW AND ICE FROM SIDEWALKS IN THE TOWNSHIP OF KING

WHEREAS paragraphs 60 to 63 of section 210 of the Municipal Act, R.S.O. 1990, Chapter M.45, provide for the removal of snow from sidewalks;

NOW THEREFORE the Council of the Corporation of the Township of King HEREBY ENACTS AS FOLLOWS:

1. In this by-law

- (a) "highway" means any street or highway located within the geographical boundaries of the Township of King;
- (b) "Township" means the Corporation of the Township of King;
- (c) "sidewalk" means the portion of the road allowance located between the paved portion of the street and the property line, so constructed for the purpose of transporting pedestrians, up to a maximum width of 1.5 metres, or the actual constructed width, whichever is the lesser.
- 2. The designated class to which this by-law applies shall be all owners or occupants of lands or premises in the Township of King which front or abut on the side of the highway upon which there is a sidewalk.
- The occupant of every parcel or land or premises which fronts 3. or abuts on the side of any highway upon which there is a sidewalk, or in case there is no occupant, the owner or person or persons having control of such land or premises shall, within twenty four hours after any fall of snow, rain or hail shall have ceased, remove or cause to be removed entirely from the portion of the sidewalk opposite such land or premises snow and ice resulting from such fall of snow, rain or hail; and whenever and as often as any part of the surface of such portion of the said sidewalk shall, notwithstanding the removal of said snow and ice, have become slippery from any cause whatsoever, such occupant, person or persons, as the case may be, shall immediately upon such slippery condition having come into existence, sprinkle or cause to be sprinkled such portion of the said sidewalk with sand, salt or some like suitable material in such manner as to thoroughly cover such slipper surface.
- 4. (1) In case the snow and ice referred to in section 3 shall not have been removed from the sidewalk with the twenty

four hour period referred to therein, or in case any part of the surface of any sidewalk has become slippery and has not been sprinkled at the time as and in the manner prescribed in the said section, the Township may, at the expense of the owner of such land or premises cause such snow and ice to be removed or such slippery surface to be sprinkled as and in the manner aforesaid.

- (2) In every case, the Township shall keep an account of all costs and expenses of and relating to such work and materials and of the land or premises opposite to which such work has been done, and such expense shall be payable by the owner thereof and shall be added to and form part of the municipal taxes to be imposed upon the said land or premises for the year following that in which the work is done and the Township shall have the same rights, powers and remedies against and in respect of the said owner and the said land and premises as though said expense was taxes levied under the provisions of the Municipal Act.
- 5. The provisions of sections 3 and 4 shall extend and apply to the occupant, owner, person or persons, as the case may be, of any parcel of land or premises situated at the intersection of two or more highways and to the portion of the sidewalk or sidewalks located on the intersection or intersections adjacent to such parcel of land or premises.
- 6. The Township shall remove or cause to be removed snow and ice from the portion of the sidewalk located on a highway fronting or abutting any land or premises at no cost to the owners or tenants in one or two family dwelling houses where:
  - (a) those resident owners or tenants are 65 years of age or over and where there is no relative or other person under the age of 65 years residing on the premises;
  - (b) those resident owners or tenants are 65 years of age or over and where there is a relative or other person under the age of 65 years resident on the premises but is determined by a qualified physician to be incapable of removing snow and ice from the sidewalk without danger to their health;
  - (c) those resident owners or tenants who are under 65 years of age and determined by a qualified physician to be incapable of removing snow and ice from their sidewalks

without danger to their health and where there is no able-bodied relative or other person under 65 years of age residing on the premises.

- 7. Notwithstanding sections 3 and 4, the Township shall remove snow and ice from sidewalks located on those highways listed in Schedule "A" attached hereto and forming part of this bylaw and sections 3 and 4 of this by-law shall not apply to owners or tenants of land or premises fronting or abutting such highways as listed in Schedule "A".
- 8. No person shall deposit, or cause to be deposited, snow or ice upon a sidewalk or a highway.
- 9. Any person who contravenes any of the provisions of this bylaw is guilty of an offence and upon conviction is liable to a fine as provided for in the *Provincial Offences Act*, R.S.O. 1990, Chapter P.33.
