NEW BI-MONTHLY BILLING CYCLE

Property owners will now receive six water bills a year instead of four, for the billing cycle ending in February, April, June, August, October, and December reflecting two months of usage.

EBILLING & PRE-AUTHORIZED PAYMENTS

Register for the Township's ebilling service to receive an electronic version of your water utility bill directly to your email.

Late payments are charged 5% after the due date. To avoid missing or late payments sign up for automatic withdrawals through the Township's Pre-Authorized Debit Program (PAD).

WHAT TOWNSHIP TAXES FUND

Garbage collection, snow removal, parks, libraries, road repair, recreation programs, facilities, fire and emergency response – these are just some of the many essential programs and services and capital infrastructure funded by municipal taxes.

BUDGET HIGHLIGHTS

- \$1M in bridges and culverts
- \$1.6M in roads and infrastructure
- \$300K in fire safety equipment
- \$300K for the Tree Planting Program
- \$300K in park improvements
- \$200K for the Asset Management Plan, Phase 2

Plus Term of Council Projects (2023-2026):

- \$86M for Township Wide Recreation Centre
- \$9.7M for 15th Sideroad to Hwy 27 & 10th Concession reconstruction
- \$2.1M for Kettleby Road reconstruction
- \$1.6M for reinterpreting the train station & church
- \$4.2M for Nobleton Revitalization Strategy

This is in addition to various reviews and studies, including the Highway 11 Corridor, Employment Lands Strategy, and Development Charge Study Update.

PROPERTY TAX DUE DATES

Property tax bills are mailed twice a year, once in January and once in June. Each tax notice has two due dates on it. The interim tax installments are due:

- February 21, 2024 (1st installment due date)
- April 24, 2024 (2nd installment due date)



NEW STORMWATER LEVY CHARGE

In order to fund the maintenance of aging stormwater infrastructure, the Township has implemented a new stormwater management charge. The charge is based on your individual property's MPAC value and property class. View the rates at king.ca/stormwater.



EBILLING & PRE-AUTHORIZED PAYMENTS

Register for the Township's ebilling service to receive an electronic version of your property tax bill directly to your email.

The penalty charge for late payment of property taxes is 1.25% per month on the unpaid balance. The penalty is added on the first day of each and every month during which the default continues. Avoid missing a payment by signing up for automatic withdrawals through the Township's Pre-Authorized Debit Program (PAD).
